## TERMINATION OF UNITED SUSTAINABLE SERIES – GLOBAL CREDITS FUND (“FUND”)

Thank you for investing in the Fund.

We wish to inform you that we will be terminating the Fund as the Fund has not made significant progress in terms of the fund size under management which as of 10 April 2025, stands at RM2.22 million. There are expenses that are fixed, such as the management fee, trustee fee, audit fee and tax adviser fee, in managing and administering the Fund. When the Fund size becomes too small, the management expense ratio for the Fund will increase and it would be difficult to sustain an effective, economical and efficient management of the Fund.

In view of the termination, we are no longer accepting any investment into the Fund with immediate effect and the last date of application for redemption of units of the Fund would fall on **29 May 2025, before 4:00 p.m.** and we will commence the termination of the trust in respect of the Fund on 30 May 2025.

We would like to hereby extend the following options for your consideration:

### Option 1

You may choose to receive the net cash proceeds derived from the sale of all the assets of the Fund less any payment for liabilities of the Fund and any cash produce available for distribution will be distributed to you in proportion to the number of Units held by you.

### Option 2

You may also choose to switch from the Fund to any other unit trust scheme managed by the Manager at no cost, i.e. zero switching fee and without sales charge **before 29 May 2025, 4:00 p.m.**

The termination of the trust in respect of the Fund and the winding up of the Fund is expected to be completed by 9 July 2025. The termination costs shall be borne by us.
